Motion made by Commissioner Harvey and seconded by Commissioner Beauchamp to approve and authorize the following consent agenda items 18.05.447 through 18.05.452:

18.05.447 To approve and ratify the minutes for the May 21, 2018 regular session and the May 23 & 25, 2018 special sessions.

18.05.448 To authorize County Judge to sign Addendum to the current Ray Cannedy Security Agreement for 2018-2019 pick-up rates for outlying annexes. A copy of the agreement is attached hereto as Exhibit "A".

18.05.449 To authorize County Judge to sign certificate of Substantial Completion for Project 16800.00, Wichita County DA Civil Division Office Renovation. A copy of the certificate is attached hereto as Exhibit "B".

18.05.450 To file Software Technology Inc. invoice #18051004 in the amount of \$1,618 with the County Auditor for annual maintenance on Platinum Server Software and Practice Master Platinum to be paid by transfer from 100.412.3151, Computer Software, to line as determined by the County Auditor.

18.05.451 To advertise for bids for road materials for second half of 2018 and for road preparation services.

18.05.452 To authorize County Judge to sign the TWC Data Exchange Request and Safeguard Plan. A copy of this document is attached hereto as Exhibit "C".

18.05.457 Motion made by Commissioner Harvey and seconded by Commissioner Beauchamp to approve estimate from Memo's Concrete at a cost of \$4,800.00 for a concrete pad for the oil room at the Precinct #2 Barn to be paid from Precinct #2 Supplies and Operations budget, as available, to line determined by the County Auditor.

18.05.458 Motion made by Commissioner Harvey and seconded by Commissioner Beauchamp to approve estimate from Memo's Concrete at a cost of \$2,050.00 for a concrete pad for the A/C in the Evidence Room at the Sprague Annex to be paid from the Permanent Improvement Fund.

18.05.459 Motion made by Commissioner Beauchamp and seconded by Commissioner Harvey to approve proposal from Texas Carpet Outlets for carpeting in the 78<sup>th</sup> District courtroom at a cost of \$4,845.52 to be paid from 100.510.4452, Repairs & Maintenance, Buildings, to line determined by the County Auditor.
